Supporting the Humane World for Animals Here are the official sweepstakes rules:

1. ENTRY PERIOD: Humane World for Animals Sweepstakes (the "Sweepstakes") is sponsored by and administered by Streetteam Group, Inc. ("Administrator"). The Sweepstakes begins at 11:00:00 AM PST on April 30, 2026 and ends at 11:59:59 PM PST on May 31, 2026, or until all 85,010 digital trading card packs (for a total number of [85,010] cards) in the drop are claimed, whichever comes sooner ("Entry Period").

2. SWEEPSTAKES ELIGIBILITY: The Sweepstakes is open only to legal residents of the United States who are 18 years of age or older as of the date of entry. Employees of Sponsor and its affiliated companies, agencies, and vendors, along with their immediate family members, are not eligible to participate.

In addition, the following persons are not eligible to participate in the Sweepstakes: Sponsor or Administrator; any of Sponsor's or Administrator's parents, subsidiaries, affiliates, or advertising and promotion agencies; and any employee, officer, director, representative or agent of any of the foregoing persons and the immediate family members (spouses and siblings, children and parents and their spouses, regardless of where they live) or members of the same households (whether related or not) of such individuals. Void where prohibited or restricted by law. Administrator may verify eligibility at any time. The Administrator will make any determinations of eligibility. Administrator 's decision as to eligibility is final.

3. TO PARTICIPATE: Eligible participants can enter the Sweepstakes in the following manner:

Entry Method 1: Visiting www.streetteam.net, creating an account, and purchasing Starter Pack with 4 cards (\$0.50) or a Deluxe Pack with 9 cards (\$0.99)

Entry Method 2: Visiting www.streetteam.net, creating an account to receive up to 3 free packs per day (Free 2-card Pack allowed daily). In addition to the daily free packs, participants may also receive a Free 1-Card Pack for watching a designated video on YouTube or TikTok (social video packs are in addition to, and do not count toward, the daily free pack limit).

Entry Method 3: Mail a handwritten postcard to Streetteam Group, Inc., PO Box 473, Pioneertown, CA 92268 and include the following information:

- Full Name
- Mailing Address
- Email Address
- Telephone Number
- "Humane World for Animals Sweepstakes"

Each postcard is entitled to a Free 2-card Pack allowed daily. Mail-in entry postcard and/or envelope must be written by the entrant only. Entrants are not permitted to use any third-party service to assist with the entry process in any way (as determined by the Administrator). Each postcard or envelope must be mailed individually. Bulk shipment of mail-in entries will not be accepted. Mail-in entries received after the Sweepstakes has ended due to all digital trading card packs being claimed (even if postmarked prior to such date) will be void and not honored.

Administrator will release a limited collection of digital trading card packs available in the following pack types:

Free	2 card	3 packs/day	\$0.00

All pack types draw from a single shared pool of 85,010 digital trading cards. The total number of packs distributed will vary depending on which pack types participants choose.

For illustration:

- If all 85,010 cards are claimed through Deluxe Packs (9 cards each), a maximum of **9,445 packs** would be distributed.
- If all 85,010 cards are claimed through Starter Packs (4 cards each), a maximum of **21,252 packs** would be distributed.
- If all 85,010 cards are claimed through Free Packs (2 cards each), a maximum of **42,505 packs** would be distributed.

The actual total number of packs distributed will fall somewhere within this range, determined entirely by the collective purchasing decisions of all participants. Once all 85,010 cards have been claimed, no further packs will be available regardless of pack type.

All digital trading card packs — regardless of type — qualify holders for entry into the Sweepstakes. Each card carries the chance to contain one of **51 total winning cards** available across the entire sweepstakes, which may be redeemed for one of the prizes listed below.

Limit Seventy-two (72) digital trading card packs (Free, Starter or Deluxe) per person/per day regardless of method of entry.

Entries must be received by Administrator no later than 11:59:59 PM PST on May 31, 2026 or before all [85,010] digital trading card packs are sold [85,010 cards are claimed – whichever occurs first. Any attempt by a person to use multiple identities, fraudulent transactions, cancelled transactions, or any kind of bot or automated mechanisms to gain more entries than permitted by these Official Rules shall result in disqualification in Administrator 's sole discretion. By participating, entrants warrant and represent that they agree to be bound by these Official Rules and the final decisions of the Administrator. Administrator reserves the right to disqualify entrants suspected in participating in the activities defined above, or any kind of tampering with the entry process. Entry information becomes the exclusive property of Administrator upon submission. Proof of submission of entry does not constitute proof of receipt of entry. It is the sole responsibility of the entrant to notify the Administrator in writing if the entrant changes his or her telephone number during the Sweepstakes.

4. RANDOM DRAWING/ODDS: On or before May 31, 2026 the 51 entrants that have received a winning "Instant Win" card in their digital trading card pack must claim the Prize by emailing support@streetteam.net and providing the required

information. Odds of winning are one (1) in one thousand six hundred sixty seven (1,667).

Each prize listed above is referred to individually as the "Prize." (ARV: \$89 USD each), one (1) PlayStation 5 digital edition/slim (ARV: \$599 USD each), one (1) Apple AirPods 4 (ARV: \$99USD each), twenty five (25) Chewy eGift Card (ARV: \$25 USD each), four (4) Chewy eGift Card (ARV: \$50 USD each), four (4) Chewy eGift Card (ARV: \$100 USD each) and three (3) Chewy eGift Card (ARV: \$200 USD each) The Prize will be procured, administered, and distributed by Sponsor. Prize will be delivered by Sponsor (except where noted) within sixty (60) days of winner verification, as set forth below. If such a potential winner is under the age of eighteen (18), prize will be awarded to their parent or legal guardian. If such a potential winner is not available or if there is no answer at the time any message is sent is made, a phone call will be made, if possible. Any such message or phone call will instruct the potential winner to call a specified telephone number or reply by email within five (5) days (measured in the local time zone) after the time that the notification message was left.
