OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

OFFERED ONLY TO LEGAL RESIDENTS OF THE UNITED STATES, AGE 13 OR OLDER.

Dead For Days Shirt Campaign — Here are the official sweepstakes rules:

1. ENTRY PERIOD

The Dead For Days Shirt Campaign Sweepstakes (the "Sweepstakes") is sponsored by Streetteam Group, Inc. (hereinafter, the "Sponsor"). The Sweepstakes begins at 9:00:00 AM PST on [ENTRY START DATE] and ends at 11:59:59 PM PST on August 28, 2026, or until all 2,894 cards have been depleted, whichever comes first (the "Entry Period").

Digital trading cards are distributed via Free Packs, Starter Packs, and Deluxe Packs. A total of 2,894 digital trading cards are available across all pack types. All cards are drawn from the same pool on a first-come, first-served basis. Thirty-four (34) of these cards are Winning Cards, each redeemable for a Prize as described in Section 5.

Because Winning Cards are randomly and unpredictably distributed throughout the card pool, it is possible for all 2,894 cards to be claimed before every Winning Card has been drawn — for example, if the number of cards remaining in the pool is smaller than the number of cards in the last pack(s) purchased or claimed. In such event, the Sweepstakes will end upon depletion of all cards, and any Prize associated with a Winning Card that was never claimed will not be awarded. Sponsor does not guarantee that all thirty-four (34) Prizes will be claimed or awarded.

2. SWEEPSTAKES ELIGIBILITY

The Sweepstakes is open only to legal residents of the United States who are 13 years of age or older as of the date of entry. Entrants under the age of 18 may only enter into the Sweepstakes under the supervision and with permission of Entrant's parents or legal guardian, and must obtain permission prior to entry into the Sweepstakes. Such entries shall be deemed made by the respective parent or legal guardian and will be treated as such. Any prizes awarded to entrants that are potential winners will be awarded in the name of his/her parent or legal guardian.

In addition, the following persons are not eligible to participate in the Sweepstakes: Sponsor; any of Sponsor's parents, subsidiaries, affiliates, or advertising and promotion agencies; and any employee, officer, director, representative or agent of any of the foregoing persons and the immediate family members (spouses and siblings, children and parents and their spouses, regardless of where they live) or members of the same households (whether related or not) of such individuals. Void where prohibited or restricted by law. Sponsor may verify eligibility at any time. The Sponsor will make any determinations of eligibility. Sponsor's decision as to eligibility is final.

3. TO PARTICIPATE

Eligible participants may enter the Sweepstakes through any of the following methods:

Entry Method 1 — Free Digital Entry: Visit www.streetteam.net and create an account to receive up to two (2) Free Packs (1 card each) per day at no cost.

Entry Method 2 — Mail-In (AMOE): Mail a handwritten postcard to: Streetteam Group, Inc., PO Box 473, Pioneertown, CA 92268

Include the following:

- Full Name
- Mailing Address
- Email Address
- Telephone Number
- “Dead For Days Shirt Campaign”

Each postcard entitles the sender to one Free Pack (1 card). Postcards must be handwritten by the entrant. Third-party entry services are not permitted. Each postcard must be mailed individually — bulk submissions will not be accepted. Mail-in entries received after all cards have been claimed will be void, even if postmarked before that date.

Entry Method 3 — Purchased Packs (optional — no purchase necessary to enter or win): Participants who wish to acquire additional cards may purchase Starter Packs and/or Deluxe Packs as follows:

- Starter Pack — \$0.50, contains three (3) cards. Limited to three (3) Starter Pack purchases per day per participant.
- Deluxe Pack — \$0.99, contains seven (7) cards. Limited to two (2) Deluxe Pack purchases per day per participant.

All cards — whether obtained via Free Pack, Mail-In entry, or a purchased pack — are drawn from the identical shared pool of 2,894 cards described in Section 1 and carry identical odds of containing a Winning Card. A purchase does not increase, and is not required to obtain, any entrant’s odds of winning.

The Sponsor will release a total of 2,894 digital trading cards across all pack types. Each card qualifies the holder for a Sweepstakes entry and carries a chance of being one of 34 Winning Cards, redeemable for a prize listed in Section 5.

Daily Limit: No participant may claim more than two (2) cards per day via Free Pack and/or Mail-In entry, combined. Participants who purchase packs may acquire additional cards beyond this free daily limit, subject to the per-pack daily purchase limits set forth above.

Entries must be received no later than 11:59:59 PM PST on August 28, 2026, or before all 2,894 cards have been depleted — whichever occurs first. Any use of multiple identities, fraudulent or cancelled transactions, bots, or automated mechanisms to obtain entries beyond the permitted limit will result in disqualification at Sponsor’s sole discretion. By participating, entrants agree to be bound by these Official Rules and the Sponsor’s final decisions. Sponsor reserves the right to disqualify any entrant suspected of tampering with the entry process. Entry information becomes the exclusive property of Sponsor upon submission. Submission of an entry does not constitute proof of receipt. Entrants are responsible for notifying Sponsor in writing of any telephone number changes during the Sweepstakes period.

4. RANDOM DRAWING/ODDS

On or before August 28, 2026, each entrant who has received a Winning Card in their digital trading card pack must claim the Prize by redeeming the card from the “My Collection” area of their account, emailing support@streetteam.net, and providing the required information. Odds of winning are one (1) in eighty-six (86) per card drawn.

5. PRIZES

There are thirty-four (34) Instant Win prizes available in this Sweepstakes, awarded as follows:

Shirts are available in sizes Medium (M), Large (L), and Extra-Large (XL) on a first-come, first-served basis. The size requested by a winner will be fulfilled subject to availability at the time of redemption; if the requested size is unavailable, Sponsor will offer the next closest available size, or a prize of equal or greater value, at Sponsor's sole discretion.

All prizes will be procured, administered, and distributed by Sponsor. Prizes will be delivered within sixty (60) days of winner verification. Actual value may vary based on availability and shipping. Winners will not receive cash in lieu of any prize. Prizes are non-transferable and may not be substituted, except at Sponsor's sole discretion due to unavailability, in which case a prize of equal or greater value will be awarded.

All federal, state, and local taxes on prizes are the sole responsibility of the winner. Any winner whose prize value requires tax reporting will be required to sign and return an IRS W-9 form within the timeframe specified by Sponsor and will receive an IRS Form 1099 reflecting the actual value of prizes received.

6. WINNER NOTIFICATION/VERIFICATION/ADDITIONAL PRIZE RESTRICTIONS

Potential winners will be notified by receiving a Winning Card in their digital trading card pack. Potential winner must claim the prize as set forth in Section 4. Once the winner has claimed their prize by selecting the "burn" button or emailing Sponsor at support@streetteam.net, the Sponsor will verify the winner via Sponsor's website notification/message and/or email within five (5) days following Sponsor's receipt of winner's Prize claim. If such a potential winner is under the age of eighteen (18), prize will be awarded to their parent or legal guardian. If such a potential winner is not available or if there is no answer at the time any message is sent, a phone call will be made, if possible. Any such message or phone call will instruct the potential winner to call a specified telephone number or reply by email within five (5) days (measured in the local time zone) after the time that the notification message was left. Potential winner must complete, electronically sign, and submit an Affidavit of Eligibility and IRS form W-9 (if required by law) within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. Sponsor will not provide tax advice. Potential winner must reply as instructed to identify him/herself, confirm his/her eligibility and ability to accept the Prize, and provide his/her complete contact information within such time period, or he/she will be disqualified. In the event of disqualification of a winner or potential winner, at Sponsor's sole discretion the Prize may be awarded to an alternate winner (or runner up) selected from among the remaining applicable eligible entries via the means of winner determination described herein, pending verification of eligibility. Entrants further grant Sponsor and its affiliates and sublicensees the right to use the name that you submit in connection with such content, if they choose.
